

# **Barrie Cardinals Soccer Club De Futbol INC Policy on Physical and Emotional Safety**

# 1. Purpose

To ensure a safe, inclusive, and respectful environment that fosters the physical and emotional well-being of all participants. This policy establishes zero tolerance for bullying, discrimination, racism, hateful remarks, or any behaviour that undermines the dignity and safety of others.

# 2. Scope

This policy applies to all members of the Barrie Cardinals Soccer Club De Futbol INC community, including:

- Players
- Coaches and staff
- Parents and guardians
- Volunteers and supporters

It covers all interactions during:

- On-field and off-field activities
- Online platforms and social media
- External environments such as schools or community settings

# 3. Core Principles

- 1. **Respect for All**:
  - Every individual deserves to be treated with dignity, fairness, and kindness.



# 2. Zero Tolerance for Harmful Behaviours:

• The club does not tolerate bullying, harassment, discrimination, racism, or hateful speech in any form.

# 3. Holistic Safety:

- Physical and emotional safety are equally important to creating a supportive environment for development and success.

# 4. Accountability Beyond the Field:

• Bullying or inappropriate conduct online or in school reflects on the club's values and is subject to disciplinary action if reported.

# 4. Definitions of Prohibited Behaviours

# 1. Bullying:

- Repeated, harmful behavior intended to intimidate, humiliate, or hurt another person, whether in person, online, or via other forms of communication.

# 2. Discrimination:

- Unfair treatment or exclusion based on race, ethnicity, gender, ability, religion, or other personal attributes.

# 3. Racism and Hate Speech:

• Any act or statement that demeans or dehumanizes an individual or group based on their identity.



# 4. Cyberbullying:

• Use of digital platforms to harass, embarrass, or harm others, including through messages, posts, or sharing of personal information.

#### 5. Reporting and Response Protocols

#### 1. **Reporting**:

- Incidents of harmful behaviour can be reported to the club's **Safe Environment Officer** or any trusted representative.
- Anonymous reporting mechanisms will also be made available.

#### 2. Investigation:

• Reports will be investigated thoroughly, maintaining confidentiality and impartiality.

#### 3. **Response**:

- Depending on the severity of the incident, actions may include:
  - Mediation or conflict resolution.
  - Written warnings or suspensions.
  - Permanent removal from the club for severe or repeated violations.

#### 4. Support:

• The club will provide resources and support to victims, including counselling referrals if necessary.

#### 6. Prevention and Education

#### 1. Training:

• All players, coaches, and staff will receive training on recognizing and addressing bullying and discrimination.



#### 2. Awareness Campaigns:

- Regular workshops and discussions will reinforce the club's values and commitment to safety and respect.
